AN ORDINANCE AMENDING CHAPTER 3.12 OF THE WINNEMUCCA MUNICIPAL CODE (WMC); INCREASING THE FEES AND CHARGES FOR USERS OF THE CITY RECREATION FACILITIES, INCLUDING THE SWIMMING POOLS AND THE CITY GOLF COURSE; AND, PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

Section 1. Enacting provisions. There is adopted the following to amend Chapter 3.12 of Title 3 of the Winnemucca Municipal Code.

1.1 Amendment. Winnemucca Municipal Code Chapter 3.12.010 is amended to read as follows:

3.12.010 Recreation Fees.

A. The following classifications, definitions and abbreviations shall be applicable to this section:

M/F:	Monday through Friday, except holiday
SS&H:	Saturday, Sunday or holiday
Youth:	Age 5 years through 18 years
Adult:	Age 19 years through 59 years
Senior:	Age 60 years and over
Husband and Wife:	Man and woman, married
Family:	Husband and/or wife and one or more of their children classified as a youth or full time college student.

B. The following groups of persons or organizations shall be exempt from payment of fees in accordance with this section:

1. Community and high school swimming team members for use of swimming pools.
2. Full time city employees for use of swimming pools and the weight room.
3. Volunteer firemen for use of swimming pools and the weight room.
4. Members of the high school golf team for M/F golf play.

1. Passes for swimming pool use are good at all city swimming pools.
2. Private parties may rent city swimming pools for private use at times other than normal hours of operation.
 - a. Non-profit organizations shall pay a fee of \$35.00 per hour for swimming pool rental.
 - b. Private individuals or private entities shall pay a fee of \$70.00 per hour for swimming pool rental.
 - c. A minimum of two (2) lifeguards must be on duty during any private use of city swimming pools.

D. The rates for aquacise instruction are as follows:

1. Team sponsorship fee 325.00
2. Per player fee 35.00
3. Tournament fees:
 - a. Reservation deposit of \$50.00, refundable only if tournament is held.
 - b. Cleaning deposit of \$100.00, refundable only if facility is left in the same condition as received.
 - c. Lighting charge of \$30.00 per night per field on weekends (Saturday and Sunday only).
 - d. User charge of \$60.00 per field per day (Saturday and Sunday only).
 - e. Field preparation charge of \$20.00 per field per preparation.
1. Coaches and Instructors shall receive revenue for services provided as follows:
 1. Gymnastics instructor receives 70.00% of revenue collected.
 2. Karate instructor receives 70.00% of revenue collected.
 3. Aquacise instructor receives an hourly rate as agreed upon between the instructor and the city.

1.2 Reenactments. All other sections of Title 3 of Winnemucca Municipal Code are reenacted without change.

Section 2. Concluding Provisions.

2.1 Effective Date. This ordinance shall become effective January 1, 2012 after it is published by title together with an adequate summary, including any amendments, once in a newspaper published in the City of Winnemucca and after it is posted in the City Hall, Winnemucca, Nevada.

2.2 Severability. If any provisions of this Ordinance or amendments thereto, or the application thereof to any person, thing or circumstance is held to be invalid, such invalidity shall not affect the validity of provisions or applications of the ordinance or amendments thereto which can be given effect without the invalid provision or application and to this end the provisions of this ordinance and amendments thereto are declared to be severable.

2.3 Repealer. All ordinances and parts of ordinances in conflict or inconsistent with this ordinance are hereby repealed, but only to the extent of such conflict or inconsistency. The repeal of prior ordinances provided in this section shall not affect any act done or any cause of action accrued or established or any plea, defense, bar or matter existing before the time when such repeal takes effect. No ordinance which heretofore has been repealed shall be revived by the repeals provided in this section.

2.4 Table of contents, headings and bracketed material. Any table or listing of section numbers, any headings and any bracketed material contained in this ordinance is intended as a reference aid and has no legal effect.




