

**SUMMARY:** Golf Course policies, rules and regulations and tournament fees.

**RESOLUTION NUMBER 2011-31**

**WHEREAS**, the City Council desires to make revisions to the Golf Course Policy, Rules and Regulations previously adopted by Resolution Number 2007-26 and the Golf Tournament Fees and Rules previously adopted by Resolution Number 2000-18; now, therefore,

**THE CITY COUNCIL OF THE CITY OF WINNEMUCCA DO RESOLVE:**

**1. Golf Course Policies, Rules and Regulations.** The following policies, rules and regulations apply to the use of the City of Winnemucca Municipal Golf Course ("Golf Course"):

A: Play.

1. All players must sign the register at the Club House prior to play on the Golf Course.
2. Players must have the Golf Professional approval to start on any hole, other than Hole Number 1.
3. Players finishing play on Hole Number 9 must alternate with players waiting to start on Hole Number 1.
4. Players must have the Golf Professional approval to play more than a four-some. A five-some is the maximum allowed group size. Five-some group play will be monitored to ensure that play is not held up.
5. Players may be required to speed up play and/or allow faster players to play through if their game is slowing the pace of the course.
6. The Golf Professional, or designee, shall enforce all Golf Course rules and regulations, and shall have the authority to remove any player for rule-regulation violation. Upon removal from the Golf Course, any paid fees may be forfeited, and golfing privileges may be revoked.
7. The City shall determine when winter rules will be applicable, including use of temporary greens and golf cart time-of-use restrictions.

B: Reservations.

1. All tee time reservations shall be made at or through the Golf Course Pro Shop.
2. Starting times shall be issued beginning at 8 a.m. each Monday, unless otherwise determined by the Golf Professional.
3. Tee time reservations shall not be made for less than two (2) golfers.

C: Golf Carts.

1. Any person operating a golf cart on the Golf Course must have a valid driver's license.
2. The Golf Professional may revoke the privilege of operating a cart if, in the Golf Professional's opinion, the operator is not operating the cart in an appropriate manner.
3. Golf carts must remain at least thirty (30) feet from greens and tees unless on a designated cart path. Golf cart paths must be used where available.
4. Only golf carts made by an approved golf-cart manufacturer shall be permitted on the course.

D. Golf Etiquette.

1. All standards of golf etiquette shall be observed at all times.
2. Players must rake all traps and bunkers after playing a shot.
3. Players must replace divots and repair ball marks on greens.
4. No pets are allowed on the Golf Course.
5. No practice is allowed on the Golf Course or the greens; practice is allowed only on the designated practice green and practice tee.
6. No children under five (5) years of age are allowed on the Golf Course.
7. All players must have their own set of clubs.
8. Any destructive behavior to Golf Course and/or Golf Course equipment will result in immediate removal from the Golf Course.
9. Metal golf shoe spikes, non-golf cleats and shoes with lugged soles are not allowed on the Golf Course, the practice green, the practice tee or the driving range.
10. Persons not golfing or not accompanying a golfer are not allowed on the Golf Course.

E. Miscellaneous.

1. The Golf Professional has the authority to limit or prohibit any outside food and beverage from being brought to or sold at or on the Golf Course.
2. Golf Course fees are determined and implemented by the City, and will be posted in the Club House.
3. The Golf Course Rules and Regulations must be posted in the Club House.

2. **Golf Tournament Rules and Fees.** The following rules and fees apply to tournament use of the Golf Course:

A. Tournament Play and Course Closure.

1. Tournaments shall be scheduled so as not to unduly impact the public's ability to use of the Golf Course.
2. Tournaments must be scheduled a minimum of three weeks prior to the date of the event to allow for proper notice to the public.
3. No tournament event may be held on the Golf Course that is not conducted, supervised and arranged by the Golf Professional.
4. All golf related prizes awarded to tournament players must be purchased from the Golf Professional unless another arrangement is approved by the Golf Professional.

B. Tournament Fees.

1. Fees shall apply to all closed-course golf tournaments, except as otherwise allowed by these rules.
2. Fees must be paid in full to the City prior to the event.
3. The Tournament Player Fee is \$5 per day per player with a minimum fee of \$400 for full day closure or \$200 per half day.
4. The standard green fees shall apply for all tournament players, but the applicable greens fees may be waived by the City for tournaments having at least one half of the players from outside of Humboldt County, Nevada.

C. Tournament Fee Waiver.


1. Ladies Golf Association – Tuesday morning league.


